Information concerning Sponsorships of Tibetan Children and Teenagers

We organise sponsorships for...

- children and teenagers from the Tibetan Children's Villages (TCV) in India
- children and teenagers from the TCV Outreach Programme which supports young Tibetans in need who live with their families in India
- teenagers and young adults from the TCV Scholarship Programme who need support for occupational training or further education in schools or universities after living in a TCV
- Tibetan children and teenagers from the remote Dolpo Himalayan region in Nepal

The children and teenagers are refugees from Tibet, orphans or young Tibetans who were born in exile in India and are extremely poor and in desperate need of help.

Correspondence with your Child

As a sponsor you will of course receive the address of the child, And of course we also encourage you to correspond with him or her and to send photographs and small presents such as articles of clothing, items for school such as crayons or pencil cases, toys such as footballs, jigsaw puzzles, dolls etc., English storybooks, sweeties or chocolate. But **please refrain from sending expensive gifts** such as electronic products like MP3 players, Walkmen, radios, or extravagant and expensive jewellry etc.

The value of your parcels should be kept fairly low for the simple reason that the TCV will otherwise have to pay high levels of duty on more expensive content. Very occasionally packages sent do go astray or arrive with items missing. But usually parcels reach the TCV intact. It is important to send packages **by air parcel post** - despite this costing a little more. But within India they are then distributed by aeroplane which is a far safer mode. Please ensure that all parcels are marked clearly and prominently as follows:

"Registered Parcel! No commercial Value! For Refugee Children!"

Letters should be written in English. Note that you will also receive letters from your sponsor child and an annual update from us or the TCV. If you wish to send gifts of money, for example as a birthday present, it is best to send this via our bank account or to transfer a separate annual amount. In this case you should make a note on the transfer stating e.g. "an additional EUR XY for pocket money / school equipment / clothing allowance / birthday present" etc.

Visiting your Sponsor Child

We really want you to visit your child if it is at all possible for you. You should however take into account the school schedule. There are times for example when your child will be taking examinations. We can help by letting you have school vacation times and giving you some advice on how best to plan your visit. We also organize sponsorship trips to Dharamsala and Ladakh. Please write to us by e-mail to check on the dates for these trips or if you wish to receive more information.

Is it possible to choose your own Sponsor Child?

We have to say - only to a limited extent. Please consider that we allocate children according to the urgency and degree of need. But of course we will will do what we can to reflect your wishes with respect to age, sex and origin.

Your Child's Case History

At the start of your sponsorship you will receive a sponsors's letter in English - a case history, which contains the most important details about and a biography of your child. It is very important that you quote the **child's "Roll Number**" on all correspondence and bank transactions! Please make sure you use this number to avoid any confusion because the Tibetans very often have the same names.

What does a Sponsorship cost?

The patronage costs EUR 30 per month.

Please do not forget to fill in the direct debit authorisation in the application form below (SEPA, for EU member states only)! Sponsors from non-EU countries have to transfer the monthly fee on our bank account. The sponsorship fee is used to pay for the child's upkeep including for example clothing, accommodation in the Tibetan Children's Village or hostel, medical care, school materials and food. In agreement with Mr. Tsewang Yeshi, the president of TCV, 10% of the sponsorship fee (EUR 3) goes towards administration. If, in addition to your sponsorship, you become also a Shelter108 e.V. charity patron (annual fee of EUR 60) your sponsorship fee will be exempt from the 10% administration fee.

Michael Landwehr is our sponsorship expert. He himself worked for over two years as a teacher in the Dharamsala TCV. He now has three sponsor children there. Michael knows personally all the sponsorship secretaries and most of the children in the "Upper TCV"! He knows everything about how the TCV works and what conditions are like there. This guarantees that you receive first-hand information in all matters concerning your sponsorship. He'll make sure you always get the right advice!

Is it possible to share the Costs of a Sponsorship?

If you are not able to afford a sponsorship alone it is possible to share this with a friend. However we can only book the full sponsorship fee from one account.

Donation Certification

In most countries charity donations are tax deductable. At the beginning of each calendar year you will receive certification from Shelter108 e.V. of your donations in the year previous.

Termination of your Sponsorship

You can terminate your sponsorship at any time and without having to provide reasons. It would be really helpful for your child if you would however give us ample lead-time in order that we can find a new sponsor for your child.

When does my Sponsorship finish?

Officially when the child leaves the TCV, when the child returns to its family, when occupational training is completed or when your sponsor child starts work. We will however defintely inform you. You then of course have the opportunity to keep contact with your child privately if both parties wish this to be the case.
